2. Position Purpose:

The management, maintenance, readiness and operations of NMSA's fleet of boats.

- To actively promote small craft safety, maintain effective search and rescue coordination and response.
- Maintain constant dialogue with regional partners and national stakeholders.
- Ensure departments' system and equipment are fully available and functioning.

- Provide leadership and guidance to department and ensure staff are adequately trained and developed.
- Provide timely reports and advice to executive management.
- Ensure department activities are planned and conducted timely and within budget.
- Coordinate with responsible parties to carry out effective Search and Rescue responses.


Budget: As annually determined.

Nature and Scope:

Reporting Relationships

This position is one of five (5) direct reports to the Ex. Manager Maritime Operations and reporting to it are Chief Coordinator, MRCC; Coordinator, Small Craft Safety and Coordinator; Fleet Operations.



Work Environment

Position is located at Port Moresby office and work involves travel to Maritime Provinces to conduct SAR activities, equipment testing, provide training for officers on site and conduct investigations on incidents.
